International Fraud Awareness Week, or Fraud Week, was established by the <u>Association of Certified Fraud Examiners</u> (ACFE) in 2000 as a dedicated time to raise awareness about fraud. The week-long campaign encourages business leaders and employees to proactively take steps to minimize the impact of fraud by promoting anti-fraud awareness and education.
